For over 50 years, people with and without intellectual disabilities have shared life together at [L'Arche Toronto](#), living its mission of "creating a world where everyone belongs". As a highly regarded non-profit organization, L'Arche Toronto provides support for daily living, employment, and community participation through five homes and day supports, and two community inclusion programs: [Sol Express](#) creative and performing arts program and the [Trying It on For Size \(TIFS\)](#) advanced life skills program. As a community, L'Arche Toronto includes people with intellectual disabilities (core members), those who support them (assistants, staff, volunteers) and a wide circle of family, friends, and neighbours.

## **As a Board director, you will:**

Participate in an active and energized board, supporting the organization in living its mission and values and achieving strategic objectives

- Provide advisory and strategic input in areas such as finance, policies, and risk
- Support and provide oversight on national and international L'Arche policies and initiatives
- Be welcomed as a member of the L'Arche Toronto community to attend community events and build relationship with the community
- Be an advocate for L'Arche Toronto within the broader community

Time commitment is a 3-year term and minimum 2.5 hours per month. This includes preparation for and attendance at 10 board meetings/year. According to the Board member role and items or tasks that arise, additional time may be required in between meetings. Board meetings are held virtually with typically three in-person meetings a year in east Toronto.

We encourage applications from members of all equity seeking groups. Lived experience with intellectual disability or the developmental services sector is highly valued. No prior Board member experience is required.
